| 4   | CRAC or CRAH fan VFDs or ECMs                      | <ul style="list-style-type: none"> <li>New ECM Motors must replace existing shaded pole (SP) or permanent split capacitor (PSC) motor</li> <li>VFD must be installed on fan that does not have VFD controls already</li> <li>VFD must be used to modulate fan speed below 100%</li> </ul> | No                             | \$90.00 per fan HP                                 |

| Custom Airflow/HVAC Measure   |  |   |                                |  |
| <p>Projects with electrical savings that do not fit under the measures listed above may still be eligible for incentives of up to \$104 per peak kW savings. Custom measures must meet the following conditions:</p> <ul style="list-style-type: none"> <li>Measure must be pre-approved by program staff.</li> <li>New construction measures are eligible but must be compared against permitted energy code or industry standard practice.</li> <li>Measure must have peak summer demand savings and estimated annual savings of at least 10,000 kWh.</li> <li>Must be a measure that involves the facility HVAC system.</li> <li>Must be a measure that impacts facility airflow.</li> <li>Measure savings must be demonstrated with information provided to the program. Based on the review of information, final measure eligibility and incentivized savings will be determined by program staff. Interested customers should review specific documentation requirements with a program representative.</li> </ul> |  |   |                                |  |
| Optional Audit for Data Center Program  |  |   |                                |  |
| <ul style="list-style-type: none"> <li>If you require assistance identifying qualifying measures in your facility, there are two options for assistance. You can complete an optional audit with a qualifying participating contractor and request an audit cost reimbursement if you meet certain criteria. Audit cost reimbursement is limited to 1) up to 75% of the audit cost or 2) a maximum of \$8,700, whichever is lower. You can also request a free consultation from program staff who will identify opportunities at your facility from the measure list above.</li> <li>Interested customers can review the requirements with a program representative.
